- 3. <u>Cancellation/Force Majeure:</u> Neither party shall be liable for any failure or delay in performance under this Agreement to the extent said failures or delays are caused by conditions beyond Artist/Presenter and Owner control including, but not limited to Acts of God, natural disasters, government restrictions, epidemics, wars, insurrections and/or any other legitimate cause beyond the reasonable control of the Artist/Presenter or Owner. If performance is rendered impossible in the case of such events, both Artist/Presenter and Owner shall be respectively relieved of their obligation.
- 4. <u>College Policies:</u> Artists/Presenters hereby agree to comply with any and all rules and regulations governing student conduct at Keene State College specifically, the prohibition of alcohol and the prohibition of the possession of, use and/or sale of any controlled drug designated by the U.S. Federal Government.
- 5. <u>Indemnification:</u> The Artist/Presenter and Owner shall respectively indemnify and hold each other harmless from and against any and all claims or lawsuits asserted for damages due to personal injury, death or property damage of the other party. This indemnification shall not extend to damages arising from negligence on the part of either party.
- 6. **Effective Date:** This agreement shall be void if not properly signed and returned within ______ days of the date set in the first sentence of this agreement.
